Keyboard Proficiency Examination All music graduate students must pass a keyboard proficiency examination. This exam is designed to ensure the student's ability to use the keyboard as a tool within the framework of professional activities, and the requirements vary according to level and area of music study. This exam may be repeated as many times as necessary to show proficiency. The exam is offered at the end of each term. Students may enroll in secondary piano lessons as preparation for the exam.	¹ Students who have already fulfilled the requirements for E559, F519, or U510 may substitute additional lesson credits or additional credits of F519 or U510 (with permission of the woodwind department chair) to bring the major field total up to 36 credits. ² The last of the required recitals is to be scheduled upon the recommendation of the student's advisory committee chairperson after the qualifying examination is passed and before the defense of the document is scheduled.
